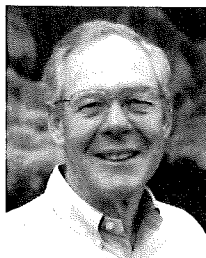

## A Quality Community

My wife Jackie and I have lived in Longmont over 40 years. Longmont is a unique community, with a small town feel that everyone appreciates and enjoys. This impression by residents and visitors alike continues to stand the test of time, regardless of Longmont's size. As Mayor, it would be my goal to consistently make and measure decisions which will positively impact the Quality of Life in Longmont. Because this is such a deeply held value in our community, we must insure that future growth is responsible growth. This means we must monitor key indicators such as traffic congestion and crime rates so that we can maintain the reasons people chose to live and work in our community.

## Safety and Security

We are fortunate to have a Public Safety Department that works in partnership with our citizens in creating and preserving exceptional public safety for those who live, work, and play in our community. The results of these efforts have led to a reduction in crime that is the envy of other communities of our size. As Mayor, I will fully support maintaining appropriate resources for our public safety needs.

## Fiscal Responsibility

I will work to ensure that the city is being fiscally responsible with its spending and costs. At this time, I am particularly concerned about the push by a majority of the City Council to acquire more water storage capacity in Chimney Hollow than our community will need at build out. The proposed utility rate increases required to acquire excess storage capacity will inappropriately impact current residents who are low-income or on fixed incomes.

## Sustainability

Longmont's Vision of Sustainability is "An engaged community that promotes environmental stewardship, economic vitality, and social equity to create a sustainable and thriving future for all." I support this vision. All of the City Council's decisions should conceptually have a sustainability aspect to ensure there is an outcome that is both of high quality and a lasting duration.

## Economic Development

It's important that our community provides employment opportunities for our citizens. Attracting and maintaining companies that provide jobs that are desired by our work force is fundamental to maintaining a strong financial base for Longmont. I will work to see that Longmont is competitive in attracting high paying, clean jobs to our community. If incentives are appropriate to attract a business to our community, I will insist that the cost benefit to Longmont is clear.

## Experience in the Private Sector

Over 30 years as a USWest Executive with management experience both domestically and internationally. Present occupation is Financial Advisor. The City of Longmont has a budget exceeding 250 million dollars and I have a good understanding of operations of this size and complexity.

## Experience in the Public Sector

Over ten years as City Council member from 2000 to 2007 and Mayor of Longmont from 2007 to 2009. I am formerly a board member and treasurer of Foothills United Way and presently a board member and treasurer of Hover Community Senior Center. I served on the Boulder County board of the Long Term Flood Recovery Program from 2015 to 2017 until the program was completed, dispersing over 15 million dollars to 1300 households.
