**General Meeting Minutes**  
Thursday, September 19, 2019  
**Ballot, Senior Center & Meals On Wheels**

1. Vice Chairman Drew Cramer called the meeting to order at 6:35pm
2. Approval of agenda – approved as amended
3. Approval of the minutes – meeting minutes from last meeting 6/20/19 were approved as written
4. Identification of new members and visitors:  
Kensington Park – Charlie Beck, & Shadowgrass – Tracy
5. Councilman Tim Waters cannot attend due to prior commitment.
6. **Public Safety Update** – Commander Hulett presented the most recent information, with car break-ins being the most frequent issue. He also reviewed how residents with private cameras can register with the City to make their videos available in instances where the information might be helpful in resolving a specific nearby issue. Anyone wishing to register a camera can do so on the public safety services – crime – neighborhood surveillance.
7. **November Ballot Initiatives:** Assistant City Manager Sandi Seader and staff presented the basics of the Longmont issues that will be on the November ballot. They presented both pro and cons factors for each ballot item.
8. **Senior Center Services:** Brandy Queen, Counseling and Resource Education Coordinator presented a wide variety of services that are available to Longmont Seniors, and in some instances to other residents. She has two resource specialists that assist her, and left a hand-out card with much more information on it.
9. **Meals on Wheels:** Katie Wiser, Development and Communications Manager, presented a very informative overview of all the services that our local Longmont Meals and Wheels provide to our community. Longmont has the largest number of people served in Boulder County, and also is the largest in Colorado. The offer Home Delivered Meals, Lunch Break for Seniors at the Senior Center M-F, Project Homecoming – 5 free meals for everyone after a hospital or rehab stay, Lockbox Program through the Senior Center to provide extra key access in emergencies and wellness visits, Emergency Pet Assistance, and Volunteer Opportunities.
10. Staff business and discussion:
  - NAF Rolling Fund update:** 7 activities have been approved (\$1,190) and \$160 remains. The deadline to apply for neighborhoods who have not yet received funds for an activity is November 1, 2019.
  - NIP 2020 Proposal Deadline:** 9/25/2019
  - Slow the Flow Water Audits:** Audits are still available, and Northern Water has a grant program that would work for larger projects.
  - Leadership changes:** Any changes in NGLA representatives require a mid-year leader update form.
  - Non-Profit and Community Organizations Spotlight (schedule & ballot)** A ballot will be sent out and each NGLA representative needs to vote their 3, in order, most preferred and returned before/at October meeting.
  - Groups will present at the November meeting.** Regional groups may now be considered, please submit suggestions.
